## II. SETUP—LOCATION, RECEIVING, & PLACEMENT

#### **Selecting a Location**

In selecting a location for your washer, the following factors should be given consideration.

- Near utilities required see dimension sheet.
- Near an outside wall or directly under a roof for inexpensive ventilation hook-up.
- Ample floor space.
- Easy access for inspection and maintenance.
- Accumulation area for cleaned and soiled pans.

#### Receiving

The machine is provided in one main section, with accessory items located inside. The doors are wired shut. Remove the wire from the door and the shipping blocks from under counterweight on the side of the machine.

Inside the washer, you will find the work tray, exterior rinse piping assembly and any accessory equipment that has been purchased, such as exhaust fan, booster, baskets and racks. The items will be banded together. Accessory items and rinse piping should be unbanded and removed from the machine. Do not remove the work tray. Some items may be crated separately.

Installation tips, maintenance and operating manual is located inside control enclosure. To prevent damage: before start-up, place green solenoid coil back onto the exterior rinse valve body located on top of washer.

#### **Placement**

After machine has been removed from the shipping crate, spot in the desired location. At this time, make sure machine has enough clearance all the way around for future maintenance and removal of components. Machine can also be leveled at this time by adjustment of the legs. Make sure there is weight on all four (4) legs after adjustment.



Note: Fresh water rinse requires 76 GPH @ 20 PSI line flow pressure.

#### II. SETUP—SERVICE CONNECTIONS

#### **Service Connections**

Refer to dimension sheets for location of each service connection. Drawing is enclosed in installation package.



**Caution**: It is recommended that a fused safety switch be provided in the line to disconnect the circuit to permit work to be done on the machine without danger of shock. The outside power line should be connected to L-I, L-2 and L-3 on the terminal block (See Wiring Diagram inside control panel).

#### TANK WATER FILL/FRESH WATER RINSE

The tank is filled automatically through the fresh water rinse line. The tank will fill until the solution reaches a preset level in the main tank. The washer will shut off automatically. Door must be closed to operate auto water fill.

#### START UP

Unlock and turn "ON" main disconnect switch (provided by others). Turn "ON" the washer's power switch located on the front of the washer's control panel. A "WHITE" indicator light will come on.

Push the "GREEN" start button and allow the washer to fill the wash tank and to complete one (1) cycle. A cycle is complete when the "RED" cycle end light goes off.

#### **VENTILATION**

A 3 1/2"inside diameter watertight duct is required for Model SL-2S. Be sure to use proper inside lapping of joints and to use the provided gasket between the fan and washer housing so that condensate is not permitted to seep out at the connections.

#### **ROTATION OF MOTORS**

On initial start-up, the motors should be checked to make sure they are running in the proper direction as shown by the arrows.

#### **TANK PREPARATION**

Flush out tank after draining, to remove any foreign substance that may have collected during shipment.

Remove filter screens and flush out. Close drain valve, close door and push auto water fill button.



**Note**: The SL-2S washer incorporates a safety circuit that will NOT allow the pump to operate until the tank is filled to the proper fill depth. Electric heating elements will not operate unless tank is full of water.



**Note**: During the first week of operation, it will be necessary to watch the spray nozzles for any chips or scale, which may have collected. If this occurs, remove the clogged nozzles, clean and replace.

#### **Daily Startup**



**Note**: The start up procedures listed below, are for tanks with steam, and electric heat, sources. Please check to see which heat source is provided with your washer.

Unlock and turn "ON" main disconnect switch (provided by others).

Turn "ON" washer's main power switch. A "WHITE" indicator light will come on. Close the door to activate the water fill. The water fill system will automatically allow the wash tank to be filled with water and shut off when the proper level is reached.

Set the wash temperature controller, located on the front of the main control panel to 150° F / 71.1° C (See temperature controller manual for setting instructions). When the temperature for the wash tank reaches the 150° F / 71.1° C set point, the washer door can be opened and a rack can be loaded. At this time, adjust the wash cycle switch to the light, medium or heavy soil position depending soil conditions. The "GREEN" cycle start button can now be pushed. A "RED" in cycle light comes "ON". The light stays "ON" until the cycle is complete. When the light goes "OFF", the cycle is complete and the door to the washer can be opened and the rack removed.

# ACTIVATING STEAM HEATING ASSEMBLY (STEAM INJECTOR OR STEAM COIL)

- 1. Turn main power switch off (provided by other) and open control panel.
- 2. Set temperature control located in the main control panel, to the desired operating temperature (140° F to 160° F).
- 3. Close control panel door and turn main power switch (provided by others) back on.

- 4. Turn all steam valves to the "ON" position.
- Turn control panel tank heat switch to the "ON" position.

#### ACTIVATING ELECTRIC HEATING ASSEMBLY

- 1. Turn main power switch (provided by others) off and open control panel.
- 2. Set temperature control located in the main control panel, to the desired operating temperature (140° F to 160° F).
- 3. Close control panel door and turn main power switch (provided by others) back on.
- 4. Turn control panel tank heat switch to the "ON" position.



**Note**: The SL-2S washer incorporates a safety circuit that will NOT allow the pump to operate until the tank is filled to the proper fill depth. Electric heating elements will not operate unless tank is full of water.

#### **DETERGENT**

When the solution reaches operating temperature, add the proper amount of cleaning compound at the rate recommended by your chemical supplier.

If the detergent is in a powder form, pour the powder in the filter baskets, then close the door and run the pump until all compounds have been dissolved. If the compound has been broken up or partially dissolved, this operation will go faster.



**Caution**: The cleaning compound should be the non-foaming type and should not contain a chemical substance that will injure copper or aluminum.

#### IV. SEQUENCE OF OPERATION

#### **Sequence of Operation**

- 1. Turn on main power by closing disconnect switch (provided by others).
- Close door.
- 3. Turn power switch to the "ON" position. The Tank Fill Relay, Rinse Solenoid, will energize.
- 4. After the solution level reaches the correct operating level, the Tank Fill Relay and the Rinse Solenoid will de-energize.

#### WASHER OPERATION - (Wash & Fresh Water Rinse)

After Automatic Waterfill is complete, open the door and check for the proper solution level. Load items to be washed. Close doors.

Turn Heat Selector Switch to the "ON" position. The "GREEN" cycle start button can now be pushed. A "RED" in cycle light comes "ON". The light stays "ON" until the cycle is complete. When the light goes "OFF", the cycle is complete and the door to the washer can be opened and the rack removed.

At this time, adjust the wash cycle switch to the light, medium or heavy soil position depending soil conditions. The machine will wash for a 2 minutes in the "LIGHT" position. After the Wash the pump shuts off and the Rinse cycle begins.

The machine will rinse for a 30 time interval. An exhaust dwell will follow the rinse cycle to help remove steam from the cabinet prior to opening the doors for rack removal. When the "RED" light goes "OFF", the cycle is complete and the door to the washer can be opened and the rack removed.

#### **EXHAUST FAN (If provided)**

Turn Selector Switch to the on position. When the door is opened, the Exhaust Fan, 2M; and the Green Illuminated Selector Switch will energize. The Exhaust Fan will run until either the door is closed or the switch is turned off.

#### **Shut-Down**

- 1. Turn off heat.
- 2. Drain washer completely.
- 3. Remove the filter screens and flush out tank. Clean sludge and scale thoroughly from the inside of the washer.
- 4. Prepare the washer for next start-up by filling wash tank and adding detergent. Leave the door partially open to eliminate odors.
- 5. Turn main power switch to the "Off" position and lock out the main disconnect switch (provided by others).

#### VI. SERVICE AND MAINTENANCE

#### **Wash Pump**

The SL-2S washer is equipped with a 10 HP horizontal immersion pump. The pump delivers an operating pressure of 55 to 60 lbs.

If your pump pressure is below normal, check the following:

- Pump rotation.
- Nozzles missing in spray pipe assembly.
- End caps missing on spray pipes.
- Pump suction clogged.
- Pump gauge defective.

Should operating pressure be higher than normal look for:

- Clogged nozzles.
- Discharge on pump clogged.

To prevent damage to the pump, periodic check of the following should be made:

- After any electrical work has been completed, always check motor rotation.
- Inspect impeller for any clogging.
- Grease every six months.

#### **Nozzle Cleaning and Adjustment**

Inspect nozzles once a week for clogging. When clogging occurs, remove end caps on the wash pipes. Using a small wire or screwdriver, push the debris back down into the pipe to remove the nozzle clog. Close the door and run the pump for 2 to 4 seconds to flush the debris out the ends of the pipes. Replace the end caps when finished. Excessive pump pressure will indicate clogging condition. Do not remove the nozzles from the wash pipes unless absolutely necessary. The adjustment of the nozzles has been made by the factory and is located in a pattern for the best performance.

#### **Door Cable Assembly**

The counterweight is fastened to the doors and stainless steel cables are threaded through the pulleys and held in place by cable clamps.

Replace door cables. Thread cables through holes on door strip.

Thread other end of cables through pulleys to door counterweight, insert through hole, loop back and clamp. Always double clamp for safety.

Replace grid cables. Thread cables through holes on grid. Thread other end of cables through the pulleys to the grid counterweight, insert through holes and clamp.

#### **Exhaust Fan**

Any time the doors are opened, the exhaust fan shall operate. The exhaust fan shall continue to run until the doors are closed, or if they are left open for longer than five minutes of inactivity.

### Steam Booster (as provided)

The primary function of the steam booster is to raise water temperatures to 180 degrees to meet sanitation requirements for rinsing. When installing the booster, it will require the following services:

- <u>Steam</u>: Maximum 10 PSI flow rate. Higher pressure will result in unsatisfactory results.
- Water: Design flow pressure is 20 PSI 120-140 degree F. incoming water temperature.
- <u>Electric</u>: connects for solenoid if booster is not factory mounted.
- Other: Condensate return required.



**Note:** This booster has been designed to operate on specific pressures, temperatures and volumes. If you have not supplied correct information, the booster will not perform properly. If you have supplied the incorrect information, Alvey will advise on the problem, but will not share and cost.

VI. SERVICE AND MAINTENANCE

#### Electric Booster (as provided)

The primary function of the electric booster is to raise water temperatures to 180 degrees to meet sanitation requirements for rinsing. When installing the booster, it will require the following services.

Water Design flow pressure is 50 PSI 120-140 degree F. incoming water temperature at the inlet of the booster and maintain 20PSI inlet pressure at the inlet to the rinse manifold. Electrical connections for the electric booster are to be provided by others.

#### **Lubrication Guide**

Pump Motor: Grease twice yearly.

Exhaust Fan & Motor: No greasing required.
